Personal statement of clinical and research objectives:

Throughout my education and training experiences I have developed multi-faceted skill set in clinical treatment, public health and translational research utilizing community-participatory frameworks, secondary data analyses and mixed methods approaches. My life experience, education and clinical training has helped me to develop capacity to create and deliver educational experiences in the areas of Indigenous

ethnopsychologies, Indigenous Traditional Knowledge frameworks (Anishinaabe, Dakota, Lakota), clinical psychology, public health, and research methodologies. With respect to clinical practice, I have been fortunate to develop and facilitate group therapy content and processes utilizing culturally-sensitive methods with American Indian youth and adolescents, in support of the development of critical skills for positive and adaptive functioning. At the individual level, I have utilized both, empirically-supported treatments and cultural/traditional knowledge, to assist in the care and treatment plan of children, youth. Looking back, my most valuable and rewarding experiences as a health care provider, have been roles where I am an important part of treatment teams within integrated primary care medical settings, as well as community-based mental health clinics, treating the whole person. With respect to mental/behavioral health care, in particular, I believe that we exist according to our original teachings, and healing in that sense must be consistent with these teachings, in order for us to achieve balance in our minds, hearts and bodies. In this way, I hope to help organize and employ mental/behavioral health services that center on community health resources already in existence to realize the potential of community-based health practitioners through seamless communication and translation of services, from community to clinic.

In addition, my interest in research parallels my clinical interests and experiences. In particular, I hope to remain active in developing a research agenda investigating social determinants of health within American Indian communities, while contributing to the efficacy and applicability of Indigenous epistemologies and ontological beliefs in alleviating public health problems, namely, depression, suicide and substance abuse. In addition, I want to engage community-based participatory research (CBPR) frameworks to elaborate on the mechanisms by which cultural belief systems can function as foundational frameworks to establish prevention and intervention programs within American Indian communities. This extends also to critical examination of the ethics of health research with American Indian, First Nations and Indigenous communities on Turtle Island, from Indigenous perspectives. Most importantly, I am establishing a research program that acknowledges Indigenous Ecological Traditional Knowledge and traditional cultural practices as critical in the efforts to combat climate change and environmental injustice.

Lastly, as an educator, I aspire to center spaces within Traditional Indigenous pedagogy, recognizing the active process of decolonization and reclamation that is important to reconcile the divergence of Indigenous and Western/settler-colonial epistemologies. Furthermore, I want to provide educational opportunities to youth and young adults that centers on holding space to nourish cultural continuity, both for the self and self-in relation to community, from Indigenous perspectives of thought and being. As such, I see education as a tool that can inspire people to grow and nourish their families and communities. Therefore, enlisting community members and elders to assist in educational experiences would be among my priorities in this area, especially in efforts to revitalize tradition and language in the learning spaces.
