Research Currently in Progress

"Can Auditor Responses Mitigate Unfavorable PCAOB Inspections" (On-Going). We extend Daugherty, Dickens and Tervo (2011) and Abbott, Gunny and Zhang (2013) with an investigation of the mitigating effect of auditor response type on auditor reputation damage resulting from auditor criticisms in PCAOB inspection reports. We test for an effect on audit quality perceptions in the eyes of audit committee members and investors. We find that audit committee members are significantly less (more) likely to dismiss GAAP deficient auditors that respond indicating that criticisms are due to differences in professional judgment (documentation issues). We also find that clients experience significantly higher inspection report release abnormal returns when their GAAP deficient auditor's response indicates that criticisms either were the result of differences in professional judgment or have been addressed in accordance with professional standards. These results extend the growing literature on auditor reputation effects of PCAOB inspection reports.

"Political Ideology and Risk Taking In Credit Unions" (Planning).

We plan to test the impact of the ideologies of credit union managers and employees on the riskiness of credit union decisions. We've applied a hybrid of hand collection and computerized matching to assemble measures of the ideologies of credit union managers and employees in the US. We're currently discussing model specifications. We anticipate having a draft of our study by the end of this summer.

"The Dodd-Frank Conflict Minerals Provision: An Update on First Year Compliance" (On-Going). We update readers with the results following the first year after implementation of Dodd-Frank Act's Conflict Minerals provision. We summarize the types of disclosures that companies provided.
